Endowment Grant Fund (formerly Patron Grant Fund)

In the September Reminders, the incorrect version of the Endowment Grant Fund Application was linked to the button on the cover page with the attachments. Please disregard that document and keep the one attached to the these Reminders for future reference.

Has your conference assisted a neighbor that desired a change to their situation; someone who may need a hand up to reach their goal? If so, they could be a candidate for the Endowment Grant Fund.

The Endowment Grant Fund Program provides grants to neighbors in need in four categories: Rehabilitation Treatment, Health Treatment, Job Training, and Education. These 4 areas are defined broadly. Do not hesitate to ask an individual's goal and possible eligibility to participate in the Endowment Grant Program.

As you do your Home Visits, keep your eyes and ears open. Your next visit could be the person with a goal that seems unreachable to them. The Endowment Grant Fund could be the answer to help them along in their journey to improve their situation. The next Endowment Grant Advisory Board meeting will be in November to review any applications that are submitted. **Applications are due no later than November 1**. You'll also find information and the application on our website under Member Info / Council Programs & Ministries / Endowment Grant Fund.

Conference and Member Questions and Answers (from the E-Gazette National Newsletter)

Q: We have a Conference President approaching the end of her second term and trying to plan her succession. No current member of this active Conference seems willing to step up to succeed her. If that does not change, what should happen with the Conference?

A: There are two choices, either elect someone from within or close the Conference. It is up to the Conference members to step forward and provide leadership for their Conference. A District Council president can temporarily appoint someone to be Conference President if no president is nominated before the current president term ends, but an election has to take place as soon as possible and within a reasonable time. The current president should NOT stay in office after their term has officially ended.
